Enrolment Applications ■

Application Fee

A non-refundable Application Fee of \$120.00 (incl GST) is charged for both boarders and dayboys.

This fee must accompany the Application for Enrolment Form, which may be submitted at any time. Parents of prospective students are encouraged to apply for enrolment as early as possible.

Enrolment Fee

A non-refundable fee of \$1,160.00 is required to confirm an enrolment.

Full details including the date the fee is required to secure a place and conditions of enrolment will be given to parents when the offer of a place is made, usually one year prior to entry.

Note: The Application Fee and the Enrolment Fee are required to be paid, even if enrolment is immediate.

Other Charges ■

Music Instrument Hire (where applicable)

Hire fees – for all instruments \$78.00 (incl GST) per term.

Sundry Charges

Sundry expenses (eg TAFE courses, Cadet fees, entertainment, excursions, photographs etc) which are not covered by the General Purpose Levy, will be charged from time to time on the school account.

GST may apply to some charges. Sundry charges are payable on issue of an account.

Payment of Fees ■

School Fees are invoiced prior to the beginning of each Term and are payable in advance. In 2017, fees are payable by the following dates:

Term 2	19 April
Term 3	11 July
Term 4	4 October

Overdue Accounts ■

In accordance with the Conditions of Enrolment, where fees are unpaid the School's Board of Trustees may require payment of a default charge.

Without prejudice to the Board's rights of recovery, this late payment fee will be charged on overdue amounts at 7.75% pa, or such other rate as may be determined by the Board from time to time.

The default charge will be calculated daily and compounded at the end of each calendar month, with a minimum charge to be determined by the Board.

Payment of fees may be made as follows:

BPAY -The BPAY details are on the Fee Statement. Cheque/ saving account and credit card accepted.

In Person - The Accounts office is located in School House. Office Hours: 8:00am to 4:00pm. Cash, cheque and credit card accepted.

Credit Card Charges: Visa/Mastercard/Amex 0.8%.

Building Fund ■

Overseas Student Fees ■
