General Purpose Levy

- Years 5 - 6 \$640.00 per year
- Years 7 - 12 \$1060.00 per year

Boarding Fee

Years 5 - 12 (*subject to interview*) - \$21,880 per year

This fee includes board, laundry, the provision of linen etc. and is additional to the Tuition Costs.

Health Cover

The International Student Health Cover (approx. \$600 per year) required by the Australian Government, must be paid direct to your nominated health fund at the same time as school fees are paid.

Uniforms (*estimate*)

Available at the Toowoomba Grammar School Uniform Shop:

- \$1,835 per year (new student - Years 5-12 Dayboy)
- \$2,300 per year (new student - Years 5-12 Boarding).

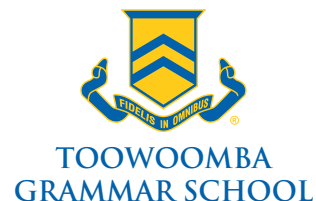
Building Fund
